# 3-4. Miscellaneous provisions

On delivery and installation, the seller must submit the delivery plan to the OIST's facility personnel beforehand, and give sufficient consideration to the existing facility by using sheet curing etc., while considering related regulations in Japan.

Seller must deliver the delivery items securely to the delivery place described at 1-4. at their responsibility.

Primal site preparation for installation/operation of instrument would be supplied by OIST. The seller is requested to provide necessary instruction to OIST's person in charge at submission of the reference quotation regarding required utilities, as follows;

- -Requirements for constructions, electricity power supply, air conditioning, piping (water supply/drain, exhaust, gas)
- -Required information for necessary notification to the government etc.

The seller must collect packaging materials and wood scraps.

The seller must cover the cost of delivery, installation and travel, accommodation, consumables for operating instruction.

If special tools are required for the usual operation and maintenance, the seller must supply them at the delivery.

Any question arising out of, or in connection with, this transaction or any matter

not stipulated herein shall be settled each time upon consultation between both parties. The seller will respect to the will of OIST as much as possible in settling such matters.

#### 3-5. Providing information regarding safety matters

At submission of quotation, seller must give a notice to OIST's person in charge if delivery items would be subject to control by the Japanese regulations such as;

- High frequency equipment (Ultrasonic washing machine etc.)
- Laser devices (Class 3R, 3B and 4)
- Radiation equipment (x-ray equipment, charged particle accelerators, devices equipped with radioactive substances, etc.)
- Local exhaust ventilation (fume hoods, push-pull type ventilation equipment, etc.)

- Class 1 pressure vessels
